Method was developed based on the theories of Stanislavski who believed that any mental act contains physical stuffs and any physical act enjoys mental stuffs. This technique was formulated by theorists such as Lee Strasberg, Stella Adler and Sanford Meissner and was quickly introduced to the world as a successful technique in the modern acting of twentieth century. On this basis, method reflection can be observed in the performance of Iranian actors and actresses like other ones in the world. Like other arts, there is no other way for qualitative growth of acting except for comparing to specialized patterns. For this reason, the main problem of this research is to compare the performance of Iranian actors and actresses to that of others who have successfully presented a character by using this method as a pattern for interaction between instinct and technique so that in this way, their attitudes to this method may be evaluated. The present research is a descriptive and analytical research with respect to method and it is a field and library research in terms of data collection. Non-random sampling method was used for selecting the subjects. - 11. Articles must be prepared by using Word 2010 software with the font B Lotus 12, margin 2/5, and line spacing 1/5.
- 12. The maximum pages of articles must be 15 in A4 paper and each page must not have more than 24 rows.
- 13. Foreign equivalents of expressions, scientific and irregular concepts and English names (the first time referred in the article) must be written as footnote on the same page.
